GENERAL INFORMATION

As part of the Community Futures Program the Community Futures Development Corporation of Middlesex County provides term loans to non-profit organizations that have had difficulty finding financing elsewhere on reasonable terms

NATURE OF LOAN:	Loans can be made to non-profit organizations serving rural Middlesex County that will be creating new jobs or maintaining existing jobs.
USAGE OF FUNDS:	Financing can be used for any legitimate business purpose, including but not limited to, the purchase of fixed assets, leasehold improvements, inventory and working capital.
FEES:	All loan application fees are waived for non-profit organizations. Applicants are responsible for all legal costs to complete the loan securitization package. These funds can be paid for from the proceeds of the loan.
INTEREST RATES:	Interest rates are currently fixed for the term of the loan at a maximum of Prime plus 2% and determined on a loan by loan basis.
TERM OF LOAN:	Loans are subject to a maximum of five (5) year term, with a maximum amortization period of fifteen (15) years. All loans are subject to regular monthly payments however, remain open for repayment, in full or in part, at any time, without penalty.
CRITERIA:	A successful application must demonstrate: <ul style="list-style-type: none">• Employment creation or maintenance for predominately local residents• A firm commitment to the operation of the organization, including an investment of funds and resources• Ability to repay the loan by way of revenues generated by the provision of local programs/services and fundraising (when applicable)• Sufficient human resources to operate the organization• Adequate security which may include a combination of corporate assets

APPLICATION PROCESS

- Applicant submits a completed Business Plan, Cash Flow and Loan Application. Please attach profiles of all principles and board members, a copy of the charter or articles of incorporation, last audited financial statements, and information regarding the organization's mission/mandate.
- Documentation is reviewed by CFDC staff
- Written review is provided to the client
- Client and staff review documentation to clarify and discuss as needed
- If the application is found to meet all requirements, a request is submitted to the General Manager for decision (loans up to \$25,000) or recommendation to the CFDC Board of Directors.
- Application / documentation is presented to the CFDC Board of Directors
- Applicant is notified of General Manager's or Board's decision
- If approved, applicant meets with CFDC staff to receive and review legal documentation to take to a lawyer
- Applicant's lawyer finalizes legal work and security documentation and returns to the CFDC office
- Funds are normally made available within 48 hours after all documentation is signed and returned
